The Diversity Index, which measures the probability that two people from the same area will be from different race/ethnic groups, is 29.4 in the identified area, compared to 64.3 for the U.S. as a whole.

Current average household income is \$61,396 in this area, compared to \$83,694 for all U.S. households. Average household income is projected to be \$72,696 in five years, compared to \$96,109 for all U.S. households

Current per capita income is \$20,772 in the area, compared to the U.S. per capita income of \$31,950. The per capita income is projected to be \$24,433 in five years, compared to \$36,530 for all U.S. households

Currently, 42.2% of the 166,720 housing units in the area are owner occupied; 52.1%, renter occupied; and 5.7% are vacant. Currently, in the U.S., 56.0% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.2% are vacant. In 2010, there were 155,881 housing units in the area - 48.9% owner occupied, 45.2% renter occupied, and 6.0% vacant. The annual rate of change in housing units since 2010 is 3.03%. Median home value in the area is \$235,997, compared to a median home value of \$218,492 for the U.S. In five years, median value is projected to change by 1.90% annually to \$259,273.
